- NSASA sponsors education and advocacy conferences to educate professionals and families in the Autism community.

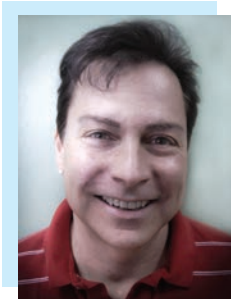

## **What is Autism?**

Autism is a complex developmental disability that typically appears during the first three years of life and is the result of a neurological disorder that affects the normal functioning of the brain.

Autism now affects one out of every 88 children (1 in 54 boys) diagnosed in the United States. Autism is that fastest growing serious developmental disability in the United States. Every 15 minutes a child is diagnosed with Autism. The treatment of Autism now costs the nation 137 billion per year. The diagnosis of Autism has increased by the rate of 100% in the last 5 years. Autism currently receives less than 5% of the research funding of many less prevalent childhood diseases.

## **Our Goals**

T Off 4 Autism has several goals:

1. To find a cause and a cure for Autism with the help of Autism Speaks and The Cody Center.
2. To provide funding for activities for children with Autism such as, skating parties, horseback riding, surfing, etc. with the help of the NSASA.
3. To expand the residential, recreational, and community integration programs for children and adults with autism through the Mental Health Association of Nassau County
4. To provide funding that will assist in the building of future housing so that children with Autism will have a brighter tomorrow.
